Mini-Course Refund Policy (for classes 6 or fewer weeks in duration)

If termination occurs during the following periods (based on the percentage of course length):

- 31 45% of the program, school may keep 50%
- 46 60% of the program, school may keep 75%
- After 60% of the program, school may keep 100%
