## **Quarter-Based Refund Policy**

A. A student who cancels within 7 days of signing the enrollment agreement but before instruction begins receives all monies returned with the exception of the non-refundable registration fee.

- B. Thereafter, a student will be liable for
- 1. the non-refundable registration fee plus
- 2. the cost of any textbooks or supplies and exams accepted plus
- 3. tuition liability as of the student's last date of physical attendance. Tuition liability is divided by the

number of quarters in the program. Total tuition liability is limited to the quarter during which the student withdrew or was terminated, and any previous quarters completed.

## a. First Quarter

If termination occurs school may keep: - Prior to or during the first week 0% - During the second week 25%

- During the third week 50%
- During the fourth week 75%
- After the fourth week 100%
