## Mini-Course Refund Policy (for classes 6 or fewer weeks in duration)

- A. A student who cancels within 7 days of signing the enrollment agreement but before instruction begins receives all monies returned with the exception of the non-refundable registration fee.
- B. Thereafter, a student will be liable for
  - 1. the non-refundable registration fee plus
  - 2. the cost of any textbooks or supplies and exams accepted plus
  - 3. tuition liability as of the student's last date of physical attendance. Tuition liability is determined by the percentage of the program offered to the student

If termination occurs during the following periods (based on the percentage of course length):

- 0 15% of the program, school may keep 0%
- 16 30% of the program, school may keep 25%
- 31 45% of the program, school may keep 50%
- 46 60% of the program, school may keep 75%
- After 60% of the program, school may keep 100%
