Quarter-Based Refund Policy

- A student who cancels within 7 days of signing the enrollment agreement but before instruction begins receives all monies returned with the exception of the non-refundable registration fee.
- Thereafter, a student will be liable for
 - the non-refundable registration fee plus
 - the cost of any textbooks or supplies and exams accepted plus
 - tuition liability as of the student's last date of physical attendance. Tuition liability is divided by the number of quarters in the program. Total tuition liability is limited to the quarter during which the student withdrew or was terminated, and any previous quarters completed.

If termination occurs school may keep: During the first week 25% During the second week 50% During the third week 75% After the third week 100%

ENROLLMENT AGREEMENT Addendum WSET Level 4, D3, Wines of the World

International Wine Center has received a special temporary exemption from the NY State Board of Education, effective from March 30th until the time when NYC is able to re-open for business.

Under this special exemption, IWC will deliver the course "WSET Level 4, D3, Wines of the World" virtually via a Zoom webinar that will enable students to actively participate.

The number of classes and total class hours remain the same. Classes will take place on the same day of the week and the same time as they would have in a classroom format. Instructors will be the same as for an in-person format.

The exam for D3 will be scheduled when it is possible to hold in-person exams.

The change in delivery format involves no additional fees to students, and the prices in the Enrollment Agreement for "WSET Level 4, D3, Wines of the World" remain in effect.
